TRUST DEED

This deed of Trust made on 16-11-99 i.e. 1999 between Shrimati Dharamsheela Singh w/o Shri Surendra Narayan Singh, by caste - Rajput, by religion - Hindu, by nationality - Indian, by occupation House wife, Resident of H.N. Singh, Road, Bindwara, who is herein after referred to a "SETTLER" of the Trust as 1st Party

2. Property of the Trust :- Rs 15,000/- (Rs Fifteen
Thousand only) donated by the
Settler.

3. Whereas the Settler being devotee and
disciple of the great saint AWADHOOT BHAGWAN
Rao of Varanashi (U.P.) the Settler has decided
to establish Trust in the memory of Awadhoot

Bhagwan Ram to serve the common men by different units and programmes.

And whereas the Settler on the inspiration of Awadhoot Bhagwan Ram has established this trust which shall be known as "SUDHARMA SAMAJIC KALYAN TRUST" an irrevocable

charitable Trust and ordinarily its head office shall be at H.N. Singh Road, Bindaara, Police Station Kaim Barar, District Muzaffar (Bihar) or at any other place as the trustee may decide from time to time.

AND WHEREAS donation amounting to Rs 15,000/- (Rupees fifteen thousand) have been received from Settler for the above Purpose and further fund will be collected and added to the Trust fund.

AIMS AND OBJECTS

1. This Trust is being established in the memory of "Awadhoot Bhagwan Ram" shall function for cultural and academic various educational activities, as to be decided by the Trust Board time to time.
2. That the Trust board shall carry on the different activities and organise symposium, debate, meetings, competitions, conference for the educational environment.

3. That the Trust Board shall construct 1 building or buildings on the land purchased or hired or taken on lease or donated to the trust to establish the units to be run by the trust board.

4. That the Trust Board shall raise fund, accept donations, subscription grant of money, securities and profits of any kind from any persons having faith in the Philosophy of Mahatma Bhagwan Rao.

5. That the Trust Board shall print and publish the book and magazine and shall make excursion programme for the mental, cultural and educational development of the boy and girls.

FORMATION OF TRUST BOARD AND OFFICE BEARERS

6. That the above mentioned names described in Para 1 are declared as founder trustees.

7. That the existing trustees shall have power to nominate one or more persons as trustee or trustees for life or for limit periods but the number of trustee shall not exceed the number No. 7 at any time.

8. That Shri. M. C. Asharda - Singh will be the founder, Chairman and Shri. Satish Chandra Guhya will be the founder Secretary of the Trust Board till their pleasure.

9. That amongst the five trustee members one trustee shall be the treasurer as per majority decision of the members of the trustee board.
10. That in case of death, resignation or incapacitation of any trustee, chairman or secretary, the vacancy shall be filled up by the remaining members of the trust board by their majority decision.
11. That the Bank accounts for the Trust as also for the different units/institution under the trust Board may be different but all the accounts shall run in the name of the Sudharana Samajik Rajyon Trust and the different accounts will be operated and audited as may be decided by the Trust board from time to time.
12. That all receipts of the trust or different unit/institution shall be deposited in the Bank account in the name of the trust.

13. That if the different units / institutions are created or constituted by the Trust Board, the ultimate control and the Proprietary rights shall remain vested in the Trust board.
14. That the Trust Board shall have Power to constitute, from the Executive Committee or managing

committee by the majority decision of the members of the Board will function under the supervision and direction and control of the trust Board, IN case of non-compliance of the direction of the trust board it shall have power to reconstitute the executive committee or managing committee, or any other bodies which may be constituted.

15. That the trust shall constitute guidelines for the functioning of the trust which shall be subject of the approval of the trust board by majority and shall be liable to be amended only by the majority

decision of the board of trust IN case of equality of votes the Chairman of the Trust board shall have casting votes.

16. That the trustees shall have power to employ permanently or temporarily and Person and or to terminate his/their services without any prior notice.

17. That the trust may request any Person of status to function as a Patron of the trust for a period of three year maximum for two consecutive terms who shall have the role of assisting the trust in its functioning and shall be deemed as a member of the trust..

18. That the trust shall hold meeting at least 3 times a year after giving at least a seven days notice prior to meeting to the trustees which will be convened by the chairman or the secretary.
19. That in the meeting of the trust the presence of either the chairman or the secretary shall be must but the absence of any other member will not invalidate the proceeding.
20. That a regular proceeding book shall be maintained in which the proceedings of different meeting and shall be recorded.
- 21 The decision of the Board on any matter shall be taken by majority.
- 22 That the trust shall have the rights to transfer any of the immovable or movable property of the trust for the purpose and object of the trust which shall be decided by the trust.
23. That the trustee shall have the right to institute any suit or any other proceeding and refer any dispute to arbitration with respect to any of the properties or affairs of the trust and chairman or the secretary shall have the power to represent the trust in any legal proceeding by or as agent of the trust.

24. That if any trustee acts as a whole time office bearer or renders any special service at the discretion of the Trust he should be paid any remuneration or allowance as decided in the trust and the board shall have power to interpret the provision of the trust which shall be final and conclusive.
